

LPL FINANCIAL REPORTS MONTHLY ACTIVITY FOR MAY 2022

SAN DIEGO – **June 14, 2022** – <u>LPL Financial</u> LLC, a wholly owned subsidiary of LPL Financial Holdings Inc. (<u>Nasdag: LPLA</u>) (the "Company"), today released its monthly activity report for May 2022.

Total advisory and brokerage assets at the end of May were approximately \$1.12 trillion, an increase of \$24.6 billion, or 2.2%, compared to the end of April 2022.

Total net new assets for May were \$24.8 billion, translating to a 27.2% annualized growth rate. This included \$18.2 billion of brokerage assets and \$1.3 billion of advisory assets from CUNA that onboarded in May⁽¹⁾. Total net new advisory assets were \$5.1 billion, translating to a 10.4% annualized growth rate.

Total client cash balances at the end of May were \$67.1 billion, an increase of \$5.3 billion compared to the end of April 2022. Net buying in May was \$0.2 billion.
